Client understands that the agreement to use, or selection of exercise programs, methods and types of equipment shall be student's entire responsibility, and WST, LLC shall not be liable to client for any claims, demands, injuries, damages or actions arising due to injury to student's person or property arising out of connection with the use by the student of the services, facilities, and premises (including remote sites utilized for training) of WST, LLC. Client, their heirs, executors and administrators, hereby holds WST, LLC its officers, owners, agents, independent contractors and employees harmless from all claims which may be brought against them by student or on student's behalf for any such injuries or claims resulting from the negligence of WST, LLC or anyone on WST, LLC's behalf whether related to exercise or not, including, without limitation, personal, bodily, or mental injury, economic loss or any damage to you, your spouse, domestic partner, guests, unborn child or relatives. Accordingly, Client forever releases and discharges WST, LLC from any and all claims, demands, injuries, damages actions or causes of action. Furthermore, Client acknowledges, that WST, LLC does not manufacture fitness or other equipment in its facilities, but purchases and/or leases equipment and therefore WST, LLC may not be held liable for defective products.

Client agrees to comply with WST, LLC membership policies and club rules that may be communicated to me from time to time either in writing, through club signage or verbally. WST, LLC may in its sole discretion, modify the policies and any club rule without notice at any time. WST, LLC reserves the right to refund the pro-rated cost of unused services and terminate my membership immediately for violation of any membership, policy or club rule.

As part of the programming at WST, LLC promotional photography and video may be used at times and Client understands that they may appear in videos and photos used for future promotion of WST, LLC and for the education/evaluation of student athletes.

CANCELLATION: If by reason of death or permanent disability, the client is unable to continue the membership, client or client's estate shall be relieved from the obligations of this contract, and if client has prepaid any sum, that amount shall be promptly refunded. Should client permanently move their residence more than 25 miles from an affiliated area, payment on this agreement will be suspended upon payment of \$50.00 and legitimate verification of the move. At the sole discretion of the WST, LLC, temporary holds may be placed on memberships in the event of injury, which bars full participation in any or all WST, LLC programs, with proper medical documentation. These holds may not exceed 60 days in any one calendar year.
